INVESTMENT ACTIVITY

Advance TerraFund REIT **owns land** for BGN 99.1 million (or **EUR 50.67 million**). In the total portfolio of the company after the revaluation 75% are agricultural land and 25% are urban land.

The company invests mainly in **the most fertile farmland** - **99%** are with land category from 1 to 6 (out of 10 in total, where 1 is the best land), and respectively this is in regions, where the most developed farm companies work.

As of May 31, 2008 Advance TerraFund REIT owns in total **23 720 ha** of agricultural land. The average acquisition price for the month is 3 540 BGN/dca (or **1810 EUR/ha**), and the **average acquisition price** since launch date is 2 250 BGN/ha (or **1 166 EUR/ha**).

LEASED AGRICULTURAL LAND

As of June 30, 2008 the revenues received for the agricultural year 2006-2007 are BGN 682 600 (or EUR 342 720).

For the agricultural year 2007-2008, Advance TerraFund REIT has signed **rental contracts** for 14 005 ha of agricultural land, which represents **64.68%** of the land bought as of 2007-end. The **average rental payment** is 14 BGN/dca (or **71.6 EUR/ha**) and the **total expected amount from rentals** is BGN 1 957 000 (or **EUR 1 000 000**). For the current year 2007-2008 the rent payments have been insured by the Bulgarian Export Insurance Agency (BEIA).
