Dear Sirs and Madams,

According resolution of the General Meeting of Shareholders of Enemona AD, held on 25 of July 2013, for distribution of dividend for 2011 and partial distribution of dividend for 2012 to the shareholders, holding preferred shares, issued by the Company – a total amount of BGN 1 708 819, we disclose publicly that the payment of the full cash dividend for 2011 amounting to BGN 1 077 214 starts on the 25.10.2013, the partial payment of a dividend for 2012 amounting to BGN 631 605 will start up to 14.11.2013. All the other parameters remain unchanged.
